**DIRECTIVES FOR THE UNOPPOSED MOTION COURT ON
27, 29 AND 31 JULY BEFORE LINGENFELDER AJ**

The unopposed motion court before Lingenfelder AJ for Monday 27 July 2020, Wednesday 19 July 2020 and Friday 31 July 2020 will run as follows:

1. In all matters the **draft order must be emailed in Word format** to Mr Siviwe Sidesha (registrar to Lingenfelder AJ/ Siviwe Sidesha SSidesha@judiciary.org.za by no later than 14h30 on Friday 24 July 2020 for the roll of Monday 27 July 2020; and by 14h30 on Monday 27 July 2020 for the rolls of 29 and 31 July 2020.
2. All matters in which there are **NO PRACTICE NOTES filed or the Practice note does not comply with the latest directive** must have one filed (by email to SSidesha@judiciary.org.za by no later than 14h30 on Friday 24 July 2020.
3. Where difficulty is experienced in uploading to Caselines, Mr Siviwe may be contacted to assist.
3. All matters will be disposed of on paper unless counsel wishes to make oral submissions. If this is the case, that must be clearly stated in the practice note. Counsel must, in any event, be available to make submissions in the event that clarification of any issue is required.
4. **Virtual hearings shall be heard on MS Teams.** During a virtual hearing the camera and microphone of only the counsel making submissions or the party giving evidence shall be *on* and the other party's camera shall be *off* and the microphone *muted*.

5. In the event that Lingenfelder AJ requires further submissions in respect of any aspect of a particular motion, counsel will be notified and may decide (i) to either make oral submissions or (ii) to file short heads of argument on that particular aspect.
6. The **final enrolment and proof of service of the notice of set down to the respondent** must be uploaded on CaseLines and emailed to Mr Sidesha by no later than 14h30 on 24 July 2020.

The Consolidated Directives and the memorandum (dated 8 May 2020) must be complied with.
