**URGENT COURT DIRECTIVE FOR 26 JUNE 2020 – 3 JULY 2020**

**KINDLY TAKE NOTE:**

1. Urgent applications will be heard by the Honourable Fabricius J (chamber 5.2) and the Honourable Mokose J (chamber 2.5)
2. Unless there is a material public interest involved, no cases will be heard in open court. There will be **no roll call** as was usual on Tuesday. Cases will be decided in the sequence they appear on the roll.
3. All cases are to be accompanied by succinct heads of argument, which should also indicate why the application cannot be decided on the papers as they stand.
4. In such instance the party involved must arrange a brief video conference.
5. Judgments/Orders will be delivered by the Judges secretary by email.
6. Strict regard will be had to Rules relating to urgency.
7. If cases are not ready by the time of filing at 12 noon on Thursday 25 June 2020, they will not be heard.
8. In case of a difficulty with CaseLines, kindly provide a hard copy to Charnét Swart.
9. All urgent applications should include the urgency certificate.
10. No piece meal filing of affidavits will be allowed.
