**OPPOSED APPLICATIONS**

**17 AUGUST- 21 AUGUST 2020**

1. All practitioners should note that Fabricius J will be the senior judge for the above week.
2. Applications will be allocated on the basis of practice notes, which must be hand delivered to chamber 5.5 (fifth floor) by no later than **5 August 2020 before 16h00**.
3. Such practice note must contain the following:
  - 3.1 details of legal practitioners;
  - 3.2 the issue to be decided;
  - 3.3 the estimated duration of any sort of hearing and
  - 3.4 whether the case can be decided on the papers, and, if not, why not.
4. Concise heads of argument should be uploaded on CaseLines and hand delivered to chamber 5.5 no later than **5 August 2020 before 16h00**.
5. If any party experiences difficulties with CaseLines they are requested to inform the judge's secretary per e-mail and obtain the necessary assistance from the CaseLines team.
6. If the directive is not abided by, an appropriate cost order will be made and the matter will most likely not be heard.
